Sub.: Rules Governing the Registration of Contractors for Civil, Mechanical, Electrical, Electronics Engineer Works – 2015.

All are requested to note that the existing rules for the registration of contractors are now reframed and the New Rules-2015 titled, "RULES GOVRNING THE REGISTRATION OF CONTRACTOR/S FOR CIVIL, MECHANICAL, ELECTRICAL AND ELECTRONICS ENGINEERING WORKS – 2015" are made effective from 20/05/2015.

Therefore, henceforth no new registration will be done except under the New Rules of 2015.

Booklet of the new registration rules and application form is available in Executive Engineer (Monitoring & Registration) Cell's office, on payment of prescribed charges amounting Rs.1,000/-+5% VAT separately for booklet and application form.

The existing registered contractors have to get their registration under the New Rules-2015, latest by 31st December, 2015. The existing registered contractors have to submit the new application form along with requisite scrutiny fee for class applied for.

In view of these new rules, the existing registration will come to end on latest by 31st December, 2015 and after 31st December 2015, no contractor will be entitled to quote or tender for any work unless such contractor is registered under the New Rules of 2015.

MAJOR POINTS CONSIDERED TO IMPLEMENT REFRAMED RULES

- i) Registration process is started from 20.05.2015.
- ii) Booklet having New Rules and Application Form is available in the office of Executive Engineer (Monitoring & Registration) Cell, 1st Floor, J. B. Shah Municipal Market Building, Yusuf Meher Ali Road, Masjid (W), MUMBAI – 09, Tel. No. 022 2340 3644, in working hours on working day..
- iii) Time period from 20.05.2015 to 31.12.2015 is a transition period for abandoning old registrations in context with the tender procedure.
- iv) In this period tenders will be invited from bidders registered in old registration rules as well as in reframed rules.
- v) The existing contractors, who are registered in the specific class / category / discipline, will be allowed to be continued in the existing class category & discipline in transition period, till they received Registration in new rules.
- vi) After 31.12.2015 tenders will be invited from the bidders registered in reframed rules only.
- vii) Registration will be allotted to Contractors on the basis of the date of approval of registration in chronological order starting from number 01.
- viii) In existing system contractors are having date of validity as 31st December of 2014, 2015 and 2016 whereas in new system registration will be for 3 calendar years from the date of registration, hence every contractor will have different date of validity.
- ix) In case of existing contractors having validity as 31.12.2015, 31.12.2016 and 31.12.2017, it is proposed to keep date of validity as it is for first time, and will change at the time of renewal of their registration. At present they have to pay Scrutiny Fee only, along with their application for getting registration in New System, applicable for respective class.
- x) In case of applications under process as per prevailing Rules of Registration, they have to submit new application alongwith additional documents and difference in Scrutiny Fess, if any. Their application will be process as per New Rules Of registration 2015, and registration class will be allotted according to new rules 2015.
