As per the directives of Hon. M.C. vide circular no: CA/FRM/7 dtd. 03.05.2011 the revised schedule of scrutiny fees/ Revalidation fees for the year 2017-2018 is as under :-

- I) Scrutiny fees is to be recovered for the proposal received for the issue of major /minor nalla remarks by the office of Dy.Ch.E./SWD/PC

ii) Rs. 17,740/-for total plot area between 1001 sq. mtrs. and 10000 sq. mtrs.	ii) Rs. 19520/- for total plot area between 1001 sq. mtrs. and 10000 sq. mtrs.
iii) Rs. 35,450/- for the total plot area more than 10,000 sq. mtrs.	iii) Rs.39000/- for the total plot area more than 10,000 sq. mtrs.

- II) Scrutiny fee to be recovered for the proposals received for the issue of surface S.W.D. remarks for the offices of Dy.Ch.E.(SWD) (P.C./W.S./E.S.)

i) Rs.7.00/- per sq.mt. of the total plot area subject to minimum of Rs. 2440/-	i) Rs.8.00/- per sq.mt. of the total plot area subject to minimum of Rs.2690/-

- III) Revalidation charges shall be recovered as under:-

ii) Amount equivalent to 50% of the scrutiny fees as a revalidation fee per year for surface SWD remarks	ii) Amount equivalent to 50% of the scrutiny fees as a revalidation fee per year for surface SWD remarks

The scrutiny fees / revalidation charges shall be paid either in cash or in the form of D.D. drawn in favour of M.C.G.M. The above fee schedule shall be effective from 1st April 2016.
