M/s. Totem International Pvt.Ltd. ( formerly known as M/s. Totem International Ltd. )have failed to undertake and execute Comprehensive annual maintenance contract (CAMC) for period of 5 years after completion of 12 months Defect Liability Period for the work of "Providing of security measures to WTP Bhandup Complex." which included Comprehensive annual maintenance contract (CAMC) for period of 5 years after completion of 12 months defect liability period.

This office has issued 'Show Cause Notices' on 18.12.2018 and 27.12.2018. to them. M/s. Totem International Pvt.Ltd. had sent email to this office on 21.02.2019 requesting to treat the contract as closed. Also no representative of M/s. Totem International Pvt.Ltd. attended the hearing, which was scheduled on 22.02.2019 in the office of Dy. H.E.(B.C.).

In view of above, as per sanction of competent authority of MCGM it is to inform that:

- A) M/s. Totem International Pvt. Ltd. (formerly known as M/s. Totem International Ltd.) is blacklisted/ debarred for a period of five years with effect from 01.11.2019 due to breaching of contractual obligation of executing the CAMC work of security equipments.
- B) The subject contract is thus foreclosed and following deposits with MCGM have been forfeited.
- i. Security deposit held in form of BG amounting to Rs. 4,46,305.00
  - ii. EMD of Rs.2,19,500.00
  - iii. Retention Money of Rs.1,80,550.00

Please note that M/s. Totem International Pvt. Ltd. (formerly known as M/s. Totem International Ltd. ) and its directors are blacklisted and are not allowed to compete, bid, enter into contract for supply to MCGM departments, for carrying out any work in MCGM for next five years from 01.11.2019 to 31.10.2024.

Totem International Ltd.) and its Directors and Authorised signatories whose office is situated at flat no. 201, 2nd floor, Venkat Mansion, SBH Colony, Srinagar Colony Post, Hyderabad-500 073 have been blacklisted/ debarred for a period of five years due to breaching of contractual obligation of undertaking the five years Comprehensive annual maintenance contract (CAMC) work of security equipments as per the contract of " Providing of security measures to Water Treatment Plant at Bhandup Complex.-CAMC for period of 5 years after completion of 12 months defect liability period."

M/s. Totem International Pvt. Ltd., Director, Mr. Firoze Zia Hussain, Hyderabad, all other Directors and Authorised signatories are blacklisted/ debarred for a period of five years with effect from 01.11.2019. They shall not be allowed to compete, bid, enter into contract or supply to MCGM departments, for carrying out any work in MCGM from 01.11.2019 to 31.10.2024.
