Annexure A UNDERTAKING

TO GRANT PERMISSION FOR TEMPORARY MONSOON SHED

I undersigned, Owner/Proprietor/Manager/Authorized Person of the said Shop hereby undertake as under :-
1. That is the exact location of the shed in the name of, in K/West Ward, shall be strictly as shown in the accompanying plans of the proposed temporary shed.
2. The temporary shed measured (Approx.) Sq. Mtrs., havingNo. of sheds will be allowed to be constructed by the Municipal Corporation of Greater Mumbai, for the permission period i.e. upto 30th September, 2025.
3. That this permission is temporary only for the monsoon period from 1st day of June, 2025 to 30th September, 2025.
4. That the materials for side and top covering used for the Temporary Monsoon shed shall be lighter material i.e. Tarpaulin or G.I. Sheet.
5. That this temporary monsoon shed shall be constructed in such a manner that the same can be easily removed after the expiry of the temporary permission period.
6. That I/We shall not do any sort of pucca or permanent construction of any nature on this temporary permission granted for the monsoon period i.e. upto 30th September, 2025.
7. That the temporary shed shall be constructed to the approved size and measurement and I/We shall not exceed the permitted area.

- 8. That the construction of the temporary shed shall be carried out under the direction of the Ward Engineers and to their satisfaction.
- 9. That I/We shall pay into your Office the sum of Rs. (Rupees as a Security Deposit may be forfeited in the extent of my/our failure to comply with any of the conditions mentioned in this Undertaking.
- 10. That I/We shall pay into your Office the sum of Rs. (Rupees as deposit covering the charges for the removal of this shed at my/our risk and cost if I/We fail to remove the shed on or before the date of expiry of the temporary permission.
- 11. That I/We shall submit that the location plan and block plan for the structure, the plans, cross sectional elevation, etc., showing the size of the structure with dimensions and the type of materials of the proposed construction, etc., shall be used.

- 12. That the permission shall be effective upto 30th September of the year 2025 and shall not extended further and that the temporary shed shall be removed completely including the frame work on or before the date of expiry of the temporary permission i.e. 30th September, 2025, that I/We shall intimate to the Municipal authorities in writing immediately after this shed is removed by me/us on or before the expiry date i.e. 30th September 2025.
- 13. That if 1/We fail to remove the temporary monsoon shed or nor before the date of expiry i.e. 30th September 2025, Municipal Authorities without any notice to me/us, may remove the same at my/our risk and cost and the demolition charges may be recovered from the deposit paid for this purpose and the security deposit paid by me/us may be forfeited.
- 14. That I/We shall pay the fees at the rate of Rs. Per Sq. Mtrs., area of the structure for the entire monsoon period of part there.
