The Brihanmumbai Municipal Corporation (BMC) invites sealed Spot Quotations from eligible bidders who are not blacklisted or debarred by the Brihanmumbai Municipal Corporation or any other Government/Semi-Government authority from undertaking or operating Municipal Pay & Park Schemes, for the operation, maintenance and management of the Pay & Park Scheme at the amenity parking site situated at C.T.S. Nos. 120 to 126, O.P. No. 37 and F.P. No. 82 of T.P.S.-I, Hi-Life Mall, Pherozshah Mehta Road, Santacruz (West), Mumbai – 400054, in H/West Ward.

The contract shall be awarded for a temporary period of six (06) months. However, fresh Spot Quotations shall be invited based on the revised parking rates upon finalisation and implementation of the new “Pay & Park” Policy of the Brihanmumbai Municipal Corporation, whichever is earlier.

The Blank Quotation Forms will be available from the Head Clerk (Expenditure)/Assistant Engineer (Maintenance), H/West Ward, on working days from **17/09/2026 to 23/09/2026, between 2.00 p.m. and 5.00 p.m.,** on payment of **Rs. 410/- + 18% GST.**

The quotationer shall deposit an **Earnest Money Deposit (E.M.D.) of Rs. 20,000/- (Rupees Twenty Thousand only)** with the Office of the Assistant Commissioner, H/West Ward, on any working day, excluding Sundays and public holidays, during Cash Counter/CFC working hours, i.e. from 8.00 a.m. to 8.00 p.m., on or before **23/09/2026.**

The duly filled-in and signed Quotation Form, together with all requisite documents and the E.M.D. receipt, shall be enclosed in a properly sealed/lacquered envelope and submitted personally, and not by post, on or before 1.00 p.m. on **24/09/2026,** at the Office of the Assistant Commissioner, H/West Ward, at the address mentioned above.

The Spot Quotations received within the prescribed time shall be opened at 3.00 p.m. on the same day, i.e. **24/09/2026,** in the presence of the quotationers or their duly authorised representatives who may wish to remain present at the time of opening.

The Assistant Commissioner, H/West Ward, reserves the right to accept or reject any or all of the Spot Quotations received, in whole or in part, without assigning any reason whatsoever. The decision of the Competent Authority in this regard shall be final and binding, subject to the applicable rules and regulations of the Brihanmumbai Municipal Corporation.
