## **SPOT QUOTATION NOTICE**

As per Hon'ble D.M.C. (Z-II) Sanction's under no. MDF/5289 dt. 13/02/2025 Spot Quotation are invited in sealed cover from the experience approved Municipal Registered Demolition Contractor for the demolition of building on **NO PROFIT NO LOSS BASIS** with profit obtain from all the salvageable material, having standing deposit with B.M.C.; from the demolition site of the Building is known as Mehra House, 250/C, New Cross Road, Opp. Neelam Centre, Worli, Mumbai - 400 030. (G + 2 RCC Building). This spot quotation is for demolition of building and removal and disposal of debris & salvage material. Therefore contractors are requested to visit the site & make himself thoroughly acquainted with the local site condition, nature & requirement of the work facilities for transport, nature of labour required, access storage for material & removal of wastes. The successful contractor will not be entitle to any claim of compensation for difficulties faced or losses incurred on account of site condition. The scope of the work is demolish the building and to disposal of debris & salvage material completely up to the ground level carting away the serviceable building materials and vacant site shall be handed over to B.M.C. in neat and clean condition. The blank Quotation Forms will be available with Head Clerk (Expenditure) G/South Ward on any working day except due date from 24/02/2025 to 27/02/2025 between 11:00 am to 04:00 pm on payment of Rs. 330/- + 18% GST towards form fees.

Successful quotationer will have to deposit SD i.e. Security Deposit Amount of Rs. 10,00,000/- in B.M.C. Custody. Willing quotationer should follow / be binded by the special direction / instruction mentioned as under for the work.

1. The quotationer who offers maximum amount against disposal of scrap to the B.M.C. shall be treated as a successful quotationer.
2. The scrap material (salvage items) of building will not be permitted to be shifted from site unless debris of said building is removed from site and site is cleaned.
3. Contractor will have to make their own arrangements for getting the electric supply on site for fabrication and allied works at their own cost.
4. The contractor shall comply with the provision of all labour legislation & shall keep the employees saved, harmless & indemnified against any claim.
5. The demolition of the building & disposal of debris & salvage material work shall be completed within 60 days from the receipt of the work order.
6. The contractor shall take photographs of the work site before commencing the work, during execution and after completion of work as directed.
7. Executive Engineer (B & F) G/South Ward reserved the right to accept or to reject any or all the Spot Quotation without assigning any reason whatsoever.

8. The contractor shall obtain all required permission for the job.
9. The rubbish / malba / unserviceable dismantled waste material, debris shall be property of contractor and same will have to be disposed at his own risk and cost.
10. The noise level shall be maintained within permissible limit in silence zone area during the disposal of debris & salvage material activity by the contractor as per the notifications issued by the MOEF.
11. The quotation shall remain valid at least 60 days from the date of submission of quotation.
12. The disposal of debris & salvage material work shall be carried out under the strict supervision of registered structural engineer appointed by quotationer at his own cost.
13. Before taking disposal of debris & salvage material of the building the contractor shall ensure proper disconnection of electricity, water supply and sanitary connection of the building.
14. The disposal of debris & salvage material work expected to be carried out with adequate machinery / equipments / man power etc. so as to complete the same within specified time period and contractor shall deploy adequate propping, barricading and other safety measures at contractors own cost, for safe guarding the adjoining structure / property / human lives and it will be sole responsibility of the contractor.
15. The contractor shall conform to the provision of all local bye laws & acts relating to the demolition work & to the regulations etc. of the Government & Local authorities.
16. Barricading - contractor shall provide barricading to entire plot boundaries using Galvalume Sheets at free of cost before start of the work and shall be kept forever after completion of work.
17. Weekly progress report of work alongwith before-during and after photographs shall be submitted to A. E. (B. & F.) G/South Ward.
18. Contractor shall take all safety requirements laid down by local authority & or national building code. The contractor shall be responsible for all injury / death to the workmen to person, animals things or any other damages to the surrounding properties indemnified for the same.
19. The quotationer should have carried out this similar kind work in last 03 years and shall produce the evidence of the same along with Quotation.
