The pre-bid meeting was held in the chamber of AMC(City) on 03.07.2020 at 3.00 pm in presence of A.C.(Estates), E.E.(Estates) & representatives of prospective bidders for the subject work.

On discussion, AMC (City) has directed to consider to following points in the EOI published on 26.06.2020.

Sr. no	EOI conditions to be read as
1	The time period shall be 6 months from date of issue of PO. As against earlier mentioned time period of 6 months or COVID-19 disease subsidies, whichever is earlier
2	The payment for 50% of Beds will be assured. As against earlier condition of payment will be made as per actual occupied beds certified by Dean of Jumbo facility and assured payment of 25% Beds minimum.
3	Morgue management will be the responsibility of MCGM
4.	Ambulance, Hurse ambulance, body lifter will be provided by MCGM
5.	The staff of service provider will be insured under Government Insurance policy viz. Covid Kavach as is applicable to other healthcare professionals in MCGM hospitals.
6.	The provision of accommodation of Specialists, Doctors and Nurses will be made by MCGM, nearby concerned Jumbo facility.
7.	The food for the staff of the Service Provider will be arranged by MCGM.
8.	Bidder shall provide dedicated Co-ordinator / Accountant/ Administrator for patients at their cost.
9.	The preventive emergency arrangement like Fire Fighting arrangement, Generator set arrangement, storm water dewatering, pumping arrangement to prevent water logging during monsoon, dedicated team for maintaining equipment to avoid failure of the same, etc., as required shall be provide by MCGM.
10.	The counselling room for counselling patients at each Jumbo facility centre shall be provided by MCGM
11.	At least one Portable X-ray machine and a portable ECG machine shall be provided by MCGM in each Jumbo facility centre.
12.	The size of war room existing at Jumbo facility centre shall be increased by MCGM as per the requirement of medical staff.

13.	The provision of adequate size sisters room shall be provided by MCGM.
14.	In case of force majeure condition, if the facility is required to be closed before 6 months period, the staff appointed by service provider shall be shifted at other locations as per the requirement of MCGM.
15.	The overall management of the patients including providing software application for recording patient's data will be the responsibility of MCGM.
16.	The infected staff of the service providers will be treated in the MCGM Jumbo facility centre.
17.	The prospective bidder has expressed their difficulty in vendor registration on MCGM portal.
