MCGM scheduled registered bidders in electrical /mechanical category of MCGM class 'A' or above and with similar or higher class of public sector or Govt. or semi Govt. organization OR Registered bidders in public sector or Govt. or semi Govt. organization. The bidder should have executed minimum one single job operation and non comprehensive maintenance of electrochlorination plant / pumpsets with their accessories in MCGM or government or semi government in the last Seven (7) years. Documentary proof of Work / performance certificate & plant capacities should be furnished for same. The bidders who are not registered with MCGM will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.
