## **E-TENDER NOTICE**

Subject: Supply, Fabrication, Testing & Commissioning of 4 nos. of mobile blood bank vehicles for Executive Engineer (Transport)

City Division under Dy.Ch.Eng.(SWM) Transport.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contract or for the afore mentioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Limited Proprietary/Partnership Firms/Private Limited Companies/ Public Companies/Companies registered under Indian companies' Act 2013. The contractors registered with the Brihanmumbai Municipal Corporation, (BMC) in appropriate Class as per old registration and Class as per new registration and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D(Earnest Money Deposit) shall be forfeited/recovered and an amount equal to Registration Fee of respective class shall be recovered as penalty.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Mahatenders) (https://mahatenders.gov.in). Bidder shall pay scrutiny fee, i.e. Rs.16,500/- + 18% GST as applicable, through Challan in Citizen Facility Centre of BMC. Packet C will be opened only after submission of scrutiny fee.

The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC to participate in the online bidding process of Government of Maharashtra (Mahatenders) (https://mahatenders.gov.in) Interested bidders should have valid Class III digital signature certificate (DSC) obtained from any licensed certifying authority.
