This is an E-Tender notice. The Brihan mumbai Municipal Corporation invites the following online tenders. The e-Tender copy can be downloaded from mahatenders portal (<https://mahatenders.gov.in>) under “e-procurement” section.

All interested bidders i.e. fulfilling the specified eligibility criteria, whether already registered or not registered in BMC, are mandated to get registered with BMC for e- tendering process, Login Credentials to participate in the online bidding process on the above-mentioned portal under “e-procurement”.

Three similar completed works each of value not less than the value equal to estimated cost put to tender i.e. Rs. 2.17 Lakh

Two similar completed works each of value not less than the value equal to estimated cost put to tender i.e. Rs. 2.71 Lakh

OR

One similar completed work of value equal and or not less than the value equal to estimated cost put to tender i.e. Rs. 4.34 Lakh

The work should be as per M&E USOR-2023 approved make and technical specifications. Bidder should have to visit site and submit survey report to the office A.E (M&E) LTMG hospital, one day prior to the due date. Without the survey report the tender shall be rejected out-rightly & will remain unopened.

For assessing the technical capacity of Regular, Routine and Maintenance works; similar work shall mean, satisfactorily completed the work of SITC/ CMC/ AMC/ Repair of connectivity or server system. (Performance certificate from user shall be attached with quotations.)

Document of compliance of above criteria shall be uploaded during the submission of the tender.

The value of executed work shall be brought to current costing level by enhancing the actual value of work at compound rate of 10% per annum; calculated from the date of completion to last date of receipt of applications for tenders.

c) One similar completed work of value equal and or not less than the value equal to estimated cost put to tender i.e. Rs. 8.00 Lakh

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

Tenderer shall have experience of Hospital Medical Gas system works OR Maintenance contract of Machines/works in MCGM / Semi Govt. /Govt. & Public Sector Organizations. (The copy of work order and performance certificates from the user shall be attached for the same.)

The tenderer must have experience of AMC/CMC/SITC/Repair of Hospital EPBAX/IPBAX system and /or authorization certificate from OEM for the same, failing which the offer will be considered as Non –responsive offer.

f) Two similar completed works each of value not less than the value equal to estimated cost put to tender i.e. Rs. 4.98 Lac

OR

g) One similar completed work of value equal and or not less than the value equal to estimated cost put to tender i.e. Rs. 7.96 Lac

The tenderer must have experience of similar type of work, failing which the offer will be considered as Non –responsive offer.

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent.
