

E-TENDER NOTICE

The Brihanmumbai Municipal Corporation (BMC) invites e-tender for the aforementioned work from contractors of repute, multi-disciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered in Electrical with the Brihanmumbai Municipal Corporation (BMC) with valid registration of Class"A" in Mechanical & Electrical category as per new registration rules 2016 and from the contractors /firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, The contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty. Bidding Process will comprise of THREE stages.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Mahatenders) (https://mahatenders.gov.in). **Tender fees amounting to Rs.16,500/- + 18% GST (9% CGST + 9% SGST)** will be applicable for subject tender. The tender fee should be paid online on mahatender portal. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process also with Mahatenders& obtain login credentials to participate in the online bidding process.

- i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.
- ii) The forms of Tender documents are available on the e-Tendering websitehttps://mahatenders.gov.in. The aspiring Applicants will have to downloadTender

form, from the website mentioned above. The bidder has to fill Inonline format and upload information regarding Tender Online. Also he has to download the Tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.

iii) For purchasing the Tender documents, the bidders will have to getregistered with e-tender portal (https://mahatenders.gov.in) for the e-tenderingprocess and obtain login credentials to participate in the online e-Tender process. Completion Period of the Work (15 Months):

- I. Drawings should be submitted within 1 month from LOA.
- II. Material should be supplied in 2 months from the date of drawing approved.
- III. Work should be completed within 2months (for each lifts) from date of receipt of Site clearance or PWD erecting permission whichever is later.

In terms of the 3 stage system of e-tendering, a Bidder will be required to deposit, along with its Bid, an Earnest Money Deposit of Rs.2,80,000.00/-(Rs. Two Lakhs Eighty Thousand only)(the "EMD"), refundable in accordance to the relevant clause of bid document, from the Bid Due Date, except in the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have toprovide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. The e-tender is available on MCGM portal (http://portal.mcgm.gov.in) as mentioned in the Header Data of the tender.
