

E-TENDER NOTICE

The Brihanmumbai Municipal Corporation (BMC) invites e-tender for the aforementioned work from contractors of repute, multi-disciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered in Electrical with the Brihanmumbai Mahanagarpalika, (BMC) with valid registration of Class AA in Mechanical & Electrical as per new registration rule 2015 & Class A in Mechanical & Electrical category as per new registration rules 2016 except those who are blacklisted or against whom FIR has been filled or from the contractors /firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, The contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Mahatenders) (https://mahatenders.gov.in). **Tender fees amounting to Rs.16,500/- + 18% GST (9% CGST + 9% SGST)**will be applicable for subject tender. The tender fee should be paid online on mahatender portal.b The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process also with Mahatenders& obtain login credentials to participate in the online bidding process.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Mahatenders) (http://mahatenders.gov.in). The applicants not registered with

In terms of the 3 stage system of e-tendering, a Bidder will be required to deposit, along with its Bid, an Earnest Money Deposit of Rs. 4,18,000/- (Rs. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. 

A) Eligibility Criteria

1. For Regular, Routine and Maintenance works:

1.1 Technical Capacity

The bidder should submit the authorization certificate from the OEM of latest date. The OEM should give the authorization for this Tender with full support for successful installation, testing and commissioning of Escalator including CSMC.

AND

The tenderer(s) in their own name should have satisfactorily executed the work of similar nature BMC /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

 a) Three similar completed works each of value not less than the value equal to Rs.83.47 lakh put to tender.

OR

b) Two similar completed works each of value not less than the value equal to Rs. 1.04 Cr put to tender.

OR

c) One similar completed work of value equal and or not less than the Rs. 1.66 Cr. put to tender.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

Authorized firms of Escalator's Manufacturer shall submit the Manufacturer's authorization certificate in prescribed format along with manufacturer's experience certificate(Given in SBD).

1.3 Similar Experience:

For assessing the technical capacity of Regular, Routine and Maintenance works; Similar work shall mean SITC of heavy duty escalator.

(Performance certificate from user shall be uploaded.)

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent.

Even though the bidders meet the above qualifying criteria, they are subject to be disqualified if they have:

- Made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
- Record for poor performance such as abandoning the works, not properlycompleting the contract, inordinate delays in completion, litigation history, or financial failures etc.
