## E-TENDER NOTICE

Sub: Annual works contract for masking and fencing on hire basis for various occasions /events carried out in Zone I.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender for the aforementioned work from contractors of repute, multi disciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under Indian companies' act 2013, the contractors registered with the Municipal Corporation of Greater Mumbai, (BMC) in Class 'AA' as per old registration 1992 or in Class 'AA' as per old registration 2015 or in Mechanical & Electrical Class 'A' as per new registration 2016 and from the contractors / firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, The contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.

The application be downloaded form can from Mahatender's (https://www.mahatenders.gov.in) on payment of EMD fee Rs.1,95,000/- & scrutiny fee of Rs.15000+ 18% GST for each bid. Scrutiny fee will have to be paid by the all the admitted bidder by taking challan from ward office within 03 days prior to the opening of Packet 'A' & 'B' & payable at any CFC centers of BMC wards. Failure to which, the bid documents of the respective bidder will not be opened and their bid will be treated as Non-Responsive. Scrutiny fee is non-refundable. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

All interested bidders whether already registered or not registered in NIC portal are mandated to get registered with NIC portal for e-tendering process & obtain login credentials to participate in the online bidding process. The details of the same are available on the above mentioned portal. The bidders can get digital signature from any one of the Certifying Authorities (CA"s) licensed by controller of certifying authorities namely, Safes Crypt, IDRBT, National informatics centre, TCS, CUSTOMS, MTNL, GNFC and e-Mudhra CA. BMC has also opened a Help-desk at the CPD's office to help the vendors in this regard.
