E-TENDER NOTICE

Subject: Work of overhauling and re-installation of electric actuators located at various SWD outfalls in Mumbai and penstock gates, stop logs at Mallet Bunder Outfall before Monsoon 2025 and removal and shifting of the same to SWD workshop after Monsoon 2025.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/ Partnership Firms/ Private Limited Companies/ Public Limited Companies/ Companies registered under the Indian companies' act 2013, the contractors registered with the Brihanmumbai Municipal Corporation (BMC) under category Mechanical /Electrical and from the contractors/ firms registered in Central or State Government/ Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three month'stime period from the award of contract, otherwise their Bid Security i.e. E.M.D. (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty. Bidding Process will comprise of THREE stages.

The bidders shall upload Scan copy of online paid EMD along with bid submission in packet A. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit.

SECTION 2

ELIGIBILITY CRITERIA

A) Eligibility Criteria:-

To be eligible for pre-qualification and short-listing, an Applicant shall fulfill the following conditions of eligibility:

Technical Capability:

a) The tenderer(s) in their own name shall have satisfactorily executed the work of similar nature in BMC /Semi Govt. /Govt. & Public Sector Organizations during **last seven (7) years** ending last day of month previous to the one in which bids are invited as a Prime Contractor (or as a nominated Sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied).

1. Three similar completed work of value equal and or not less than Rs. 2,08,300/-.

OR

2. Two similar completed work of value equal and or not less than Rs. 2,60,400/-.

OR

3. One similar completed work of value equal and or not less than Rs. 4,16,600/-.

The Bidder shall submit the certificate of satisfactory completion of work from the user Department of BMC / Semi Govt. / Govt. / Public sector organization, failing which their offer shall be treated as non-responsive and their Packet 'C' shall not be opened

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for tenders.

B) Financial Capacity:

Achieved an average annual financial turnover as certified by 'Chartered Accountant' equal to or minimum Rs. 3,12,400/- for last 3 financial years. To ascertain this, tenderer(s) shall furnish /upload the financial statement (Audited balance sheet) duly certified by Chartered Accountant. The turnover can be enhanced by 10% every year to bring the present level.

C) Similar Experience:

For assessing the technical capacity of Regular, Routine and Maintenance works; similar work shall mean work of repairs and re-installation of Penstock gates and overhauling & re-installation of electric actuators in BMC/ Semi Govt./ Govt./ Public sector organization.
