The BRIHANMUMBAI MUNICIPAL CORPORATION (BMC) invites e-tender (on item rate basis) to appoint Bidder for the aforementioned work from Bidders of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the Bidders registered with the BRIHANMUMBAI MUNICIPAL CORPORATION , (BMC) in Class 'A' (for M & E) as per new registration and Class 'V' as per new registration in Civil category and from the Bidders/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the Bidder who are not registered with B M C will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E. M. D. (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty. Bidding Process will comprise of THREE stages.
