The Municipal Corporation of Greater Mumbai (MCGM) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered with the Municipal Corporation of Greater Mumbai, (MCGM) in Class A as per new registration and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with MCGM will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

The bidders has to pay **Tender Fee of Rs.7,260/- + 18 % GST** as per Circular No. CA/FRG/17/dt.17.03.2025 on Mahatender portal.. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC & obtain login credentials to participate in the online bidding process of Government of Maharashtra (Mahatenders) (**<https://mahatenders.gov.in>**)

The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit.
