Subject: Supply, Installation, Testing & commissioning of electrical actuators for daily operation valves at Malad hill reservoir under AEWW(Maint)W.S./North II division.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered with the Brihanmumbai Municipal Corporation in class 'A' or above as per new registration in Mechanical & Electrical category or firms dealing in the line, contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. **E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.**

Bidding Process will comprise of Three stages.

The applicant must pay Tender Fee of Rs. **17,133.60 (Rs.14,520.00 + 18 % GST)**. Tender fees including applicable GST shall pay before due date of tender on Mahatenders portal online (As per Circular No. CA/FRG/17/dt. 17.03.2024). Also refer the bank details to be updated on Mahatender portal for acceptance of EMD / ASD. Tender Fee is non-refundable. Tender Fee is non-refundable.
