The Brihanmumbai Municipal Corporation (BMC) invites e-tender on Item rate /Percentage rate basis to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered with Brihanmumbai Municipal Corporation (BMC) in Class 'E' as per old registration and Class 'C' as per new registration in Mechanical & Electrical category or from the contractors/firms equivalent or superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

- 1) <u>Mode of payment of EMD</u>: The bidder shall pay entire amount of EMD i.e. Rs. 11,000.00 through payment gateways of GoM on URL <a href="https://mahatenders.gov.in">https://mahatenders.gov.in</a>. The bidder shall upload scanned copy of online paid EMD along with the bid submission in Packet 'A'. Any bid not accompanied by an acceptable bid security shall be rejected by the employer as non-responsive.
- 2) <u>If non-responsive</u>: "If the bidder is found non-responsive after scrutiny of Packet 'A'/ 'B', in such circumstances, <u>the bidder will be made non-responsive and financial packet C of non-responsive bidder will not be opened. However, there will not be any forfeit of EMD.</u>
- 3) Shortfalls: Maximum 5 shortfalls of curable defects shall be allowed and in case, curable defects are not complied by the bidder within given time period, the bidder shall be treated as non-responsive and such cases will be informed to registration and monitoring cell. Such non submission of documents will be considered as intentional avoidance and if three or more cases in twelve months are reported, shall be viewed seriously and disciplinary action against the defaulters such as banning/ deregistration etc. shall be taken by registration cell with due approval of the concern AMC.

## 4) **Refund of EMD**:

- a) Except successful bidder all the other unsuccessful bidders' 100% EMD paid online will be refunded automatically.
- b) The bid security of successful bidder will be discharged when the bidder has signed the agreement and / or furnished the required security deposit as elaborated in Standard Bid Document.
- 5) <u>Forfeiture of entire EMD</u>: The Existing conditions laid down in Standard Bid Document regarding forfeiture of entire bid security (EMD) shall remain unchanged.
