The Brihanmumbai Municipal corporation (BMC) invites e-tender to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/Private Limited Companies/Public Limited Companies/Companies registered under the Indian companies' act 2013.the Bidders registered with the BRIHANMUMBAI MUNICIPAL CORPORATION , (BMC) in Class 'A' (for M & E) as per new registration and Class 'V' as per new registration in Civil category and from the Bidders/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the Bidder who are not registered with B M C will have to apply for registering their firm within three months time period from the award of contract, otherwise their Bid Security i.e. E. M. D. (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty. Bidding Process will comprise of THREE stages.

The Micro, Small and Medium Enterprises registered under the MSMED Act, 2006 are exempted from paying Tender Forms fees and Earnest Money Deposits, including 241 products reserved under the scheme exclusively for Micro, Small and Medium Enterprises under the MSMED Act, 2006.

EMD Exemption: a) MSME will be exempted from deposit of EMD. Only if they are manufacturers or suppliers of various items in Bid. b) Vendor assessment certificate is not allowed for EMD exemptions. c) No exemptions in turnover or experience criteria against for MSME.
