The copy of the work order with number, date, contract period & cost of the work / completion certificate shall be annexed by the e-quotationer while uploading the offer.

Similar Experience: Similar experience means the work of Electrical wiring work in MCGM /Semi Govt. /Govt. & Public Sector Organizations .

Site Survey certificate(Annexure 'F') necessarily signed by BMC's Site Engineer of the captioned subject work, shall be submitted along with the bid.

E-QUOTATION TENDER FEES: The e-quotationer shall make payment of e-quotation Tender Fees of Rs. 363.00 + 18% GST (9% CGST + 9% SGST) on mahatender portal .
