Note:-

- i) Curable Defect shall mean shortfalls in submission such as:

 - iv. Undertakings as mentioned in the quotation document.

In packet 'A' maximum 05 nos. of shortfall of curable defects shall be allowed and in case, curable defects are not compiled by bidder within the given time period the bidder shall be treated as Non Responsive. The cases wherein if the shortfalls are not complied by a contractor, will be informed to Registration and Monitoring Cell. Such non-submission of documents will be considered as 'Intentional Avoidance' and if three or more cases in 12 months are re-ported, shall be viewed seriously and disciplinary action against the defaulters such as banning/deregistration, etc. shall be taken by the registration cell with due approval of the concerned AMC.

- ii) Non-curable Defect shall mean
 - a. In-adequate submission of EMD / ASD.
 - b. The documents evidence of technical and financial capacity with respect to Eligibility criteria as stipulated in the quotation.

Note: No communication will be made with the quotation in case of non-curable defects.

- 3. Quotationers are expected to fill their quotations documents carefully and scrutinize them before uploading them on website stated above. No verification on any ground such as mistake or misunderstanding will be allowed after the quotation is opened, recommended or accepted.
- 4. On opening of quotation, if it is found that quotationer has not submitted the required curable documents, then the quotationer shall be intimated through e-mail only and compliance

- required to be made within stipulated time period otherwise their offer shall be treated as non-responsive.
- 5. Taxes: The quotationer shall quote the rates inclusive of all taxes other than GST (Excluding GST), Levies, Duties, Cess etc. as applicable at the time of bid submission. GST as applicable shall be paid separately on submission of bills/invoice. Input Tax credit of GST as available with the quotationer will not be claim separately by BMC. However, while quoting the rates benefit of input Tax credit or Exemption shall be passed on to the BMC by way of equivalent reduction in quoted price Rates accepted by BMC shall hold good till completion of work and no additional individual claim shall be admissible on account of fluctuations in market rates; increase in taxes / any other levies / tolls etc. except that payment / recovery for overall market situation shall be made as per Price Variation. The quotationer shall quote the cost showing all applicable SGST, CGST, IGST & Other taxes if any, on various items.

Chapter XXI- Miscellaneous, section 171(1) of GST Act 2017 governs the 'Anti Profiteering Measure' (APM) As per provision of this section, any reduction in rate of tax on any supply of goods or services or benefit of input tax credit shall be passed on to the recipient by way of commensurate reduction in prices. Accordingly, the contractor should pass on the complete benefit accruing to him on account of reduced tax rate or additional input tax credit, to BMC. Further all provisions of GST Act will be applicable to the quotationer.

- 6. **Period of delivery / work** shall be **01 Months** (Including/Excluding Monsoon) from the date of receipt of work order.
- 7. Every quotation shall remain open for acceptance for 180 days from the date of opening of the quotation. As some minimum period for evaluating the various samples and obtaining approval of competent authority is necessary. Quotations specifying the validity less than 180 days shall be rejected out rightly.
- 8. The quotationer shall not withdraw his offer within the validity period. If he does so, the earnest money deposit paid will be forfeited.
- 9. The Municipal Commissioner does not bind himself to accept the lowest or any quotation and reserves the right to select one or more items of the quotation and the quotationer will be required to supply any item or items so selected at the rates quoted.
- 10. <u>Guarantee</u>: The successful quotationer shall give a guarantee for 12 calendar months from the date of supply / commissioning or completion of the work for any manufacturing defects or faulty workmanship on BMC prescribed "Maintenance Guarantee" from affixed with Rs. 100/-adhesive stamp / franking. If any defect is noticed within the guarantee period and intimated to the contractors, the same shall be rectified free of cost. Prescribed maintenance guarantee forms are obtainable from the office of the Chief Accountant, BRIHANMUMBAI MUNICIPAL CORPORATION, Head Office, Mahanagarpalika Marg, Mumbai 400 001.
- 11. <u>Terms of Payment</u>: As per Municipal procedure, the payment for work done shall be made within 30 days from the receipt of the bill subject to verification as per normal rules. In case of

- supply of article/s the payments shall be made within 30 days from the receipt of the bill subject to satisfactory test/approval of the article/s including its installation, if any.
- 12. Intending quotationers are informed that the payment of bills and other claims arising out of the contract shall be made in the name of the bank by ECS only. The quotationer, therefore, shall have to upload the information as regards the name and complete address of their bank, its branch and their A/C No. etc. along with the quotation documents. They shall also have to submit fresh information when there is any change in this regard.
- 13. Income Tax: The contractor shall pay Indian Income Tax on all payment made to him under the contract, other than reimbursement made to him by the corporation to cover payment by the contractor of minor custom dues etc. or any other payment which the contractor may make on the Corporations behalf. Under the provision of section 194 C of the Income Tax Act. The corporation is required to deduct tax from the source. Under present legislation, will deduct as Tax 2% of the gross amount of each bill submitted. Any expatriate site staff not normally residents of India, employed by the contractors shall pay personal Income Tax on all money earned and paid in India.
- 14. As per Government of Maharashtra notification, 1 % CGST TDS and 1% SGST TDS is applicable wherein the contract sum exceeds Rs.2,50,000/- exclusive of tax & cess as per the invoice.
- 15. Penalty: If the Contractor fails to complete the works and clear the site on or before the Contract or extended date(s) / period(s) of completion, he shall, without prejudice to any other right or remedy of Municipal Corporation on account of such breach, pay as agreed compensation, amount calculated as stipulated below (or such smaller amount as may be fixed by the Engineer) on the contract value of the whole work or on the contract value of the time or group of items of work for which separate period of completion are given in the contract and of which completion is delayed for every week that the whole of the work of item or group of items of work concerned remains uncompleted, even though the contract as a whole be completed by the contract or the extended date of completion. For this purpose the term 'Contract Value' shall be the value of the work at Contract Rates as ordered including the value of all deviations ordered:
 - **a)** Completion period for projects (originally stipulated or as extended) not exceeding 6 months: **to the extent of maximum 1 percent per week.**
 - b) Completion period for projects (originally stipulated or as extended) exceeding 6 months and not exceeding 2 years: to the extent of maximum ½ percent per week.
 - c) Completion period for projects (originally stipulated or as extended) exceeding 2 years: to the extent of maximum ¼ percent per week.

When the delay is not a full week or in multiple of a week but involves a fraction of a week the compensation payable for that fraction shall be proportional to the number of days involved. Provided always that the total amount of compensation for delay to be paid this condition shall not exceed the under noted percentage of the Contract Value of the item or group of items of work for which a separate period of completion is given.

- Completion period (as originally stipulated or as extended) not exceeding 6 months: 10 percent.
- ii. Completion period (as originally stipulated or as extended) exceeding 6 months and not exceeding 2 years: 7½ percent.
- iii. Completion period (as originally stipulated or as extended) exceeding 2 years: **5 percent.**The amount of compensation may be adjusted set off against any sum payable to the contractor under this or any other contract with the Municipal Corporation.
- 16. All quotationers must state the **names and addresses of all the partners** in the space provided for, in the papers. Any quotationer failing to do so, will render himself liable to have his deposit forfeited, and the contract, if entered into, canceled at any time during its currency.
- 17. If it is found that two or more persons who are connected with one another either financially or as principal and agent or master and servant, have quoted separately under different names for the same contract without disclosing connection, the same will be rejected, and the deposit will be forfeited. Any contract entered into such conditions will also be canceled at any stage and time during its currency.
- 18. The firms with common Proprietor / Partner or connected with one another either financially or as principal and agent or as master and servant or with proprietor / partners closely related to each other such as husband, wife, father / mother and minor son / daughter and brother / sister shall not quote separately under different name for the same contract.
- 19. If it is found that firms as described above have quoted separately under different names for the same contract, all such quotationer (s) shall stand rejected and EMD of each such firm / establishment shall be forfeited. In addition, such firms / establishments shall be liable at the discretion of the Municipal Commissioner, for further penal action including blacklisting.
- 20. If it is found that closely related persons as described above have submitted separate quotation under different names of firms / establishment but with common address for such establishments / firms and or if such establishment / firms though they have different addresses are managed by or governed by the same person / persons jointly or separately such quotationers shall be liable for action as in above clause, including similar action against the firms / establishments concerned.
- 21. If after award of contract, it is found that the accepted violated any of the clauses (24 to 27) the contract shall be liable for cancellation at any time during its currency in addition to penal action against the contractors as well as related firms / establishments.

- 22. In the case of Joint Stock Company, the contract must be sealed with the seal of the Company in the presence of and signed by two Directors or by a person duly authorized to sign the contract for the company authorized by a Power of Attorney, such power of attorney being sealed and signed as aforesaid. All such Power of Attorneys must be registered in the Municipal Head Office to CA(WSSD) section as aforesaid.
- 23. Postponement of the payment of the full security deposit or the execution of the contract will not be permitted by the reason of the Brihanmumbai Municipal Corporation having in possession, other deposits on account of other's or contracts, which deposits may be or become returnable to the quotationers and which they may wish to transfer as a security deposit under this contract. Such transfer will not under any circumstances be permitted.
- 24. The contractor shall not be liable for any liquidated damages for delay or for failure to perform the contract for reasons of force majeure such as acts of God, acts of the public enemy, acts of Government firms floods, epidemics, guaranteeing restriction, strike, freight embargoes and provided that the contractor shall inform within 10 days from the beginning of such delay, notify the purchaser in writing of the case of delay. The purchaser will verify the facts and grant such extensions as facts justify.
- 25. Except successful quotationer all other unsuccessful quotationers' 100% EMD paid online will be refunded automatically. In case of successful quotationers, this EMD deposit will be refunded after payment of security deposit and submission of documents required for execution of contract.
- 26. Quotations containing contradictory onerous and vague stipulations and heading conditions such as 'Subject to prior sale' "offer subject to availability of stock", "Offer subject to confirmation at the time of order", "Rates subject to Market Fluctuations" etc., are liable to be rejected out rightly.
- 27. The quotationers shall have to make their own arrangements to secure Import License and or release of controlled or scarce raw materials or parts if required by them for fulfillment of their contract. The Municipal Commissioner shall not be found to give any assistance to the quotationers in that behalf.
- 28. <u>Jurisdiction of Court</u>: In case of any claim, dispute or difference arising out of any terms and conditions of the contract, the Cause of Action thereof shall be deemed to have arisen in Mumbai & all legal proceedings in respect of any such claim, dispute or difference shall be instituted in a competent court in the City of Mumbai only.
- 29. Contractors' attention is drawn to provisions of Maharashtra Contract Labour Regulation & Control Rules 1970 and Child Labour Prevention & Control Regulation 1986 (if applicable). It is, therefore, directed that the provision therein shall be strictly followed by the contractor.

- 30. As per the above provision, if the total number of workers engaged on any contract work exceed 20 (Twenty), then, it is imperative on the part of contractor to obtain registration certificate from Labour Commissioner for the said work. The certificate shall be valid and produced during currency of contract in force.
- 31. Quotationers shall submit an undertaking for **Best price on stamp paper of Rs. 200/-** duly notarized by notary and registration number
- 32. The quotationer shall submit an 'undertaking cum indemnity bond' on stamp paper of Rs.200/-

Replacement of existing 3 nos of Air vent pipe system installed at Overhead tank pipe line of Filter plant M-IIIA Panjrapur.

PREAMBLE

• Preamble

Sub: -

Municipal Corporation of Greater Mumbai has implemented Mumbai-IIIA Project for augmentation of water supply to City of Mumbai. Under this project, the Filter Plant with installed capacity of 455 MLD was commissioned in year 2007 by WSP Department. The Plant has been handed over to H.E. Department in June 2009.

This Filter Plant constitutes of 18 nos. of Filter beds working on the principle of declining rate gravity sand filtration. The efficiency of filtration of sand beds decrease over a period of time due to clogging by suspended impurities and micro flocks present in water. Hence to maintain the filtration efficiency each bed is unclogged by back-washing the sand in bed. The process of backwashing is repeated for all 18 nos. of beds with fixed time interval. Water required for backwashing of filter bed is collected at overhead tank (OHT) through pipeline from PRV chamber. Air gathers when water accumulated in the Overhead tank. Hence an One no of Air vent pipe system is installed at beginning of the overhead tank outlet pipeline & 2 nos of air vent system are installed after the Flow control valve on the same pipeline to allow air to escape from the pipeline. If air vent is not provided or broken suddenly it may cause deformation or rupture of 900 mm dia pipeline & complete back-washing of filter bed is closed. This Air vent pipe system has been in service since 2007.

Currently this air vent pipe system is in heavily rusted condition due to constant exposure to chlorinated water as well as the external environment. This air vent pipe is made of M.S. material. Due to worn out condition, this rusted pipe may collapsed at any time. It is therefore necessary to replace this air vent pipe at the earliest with better suitable material like PPR (polypropylene Random co-polymer).

In view of above said condition, it is now proposed to replace & repair air vent pipe with new PPR pipe along with fittings, elbow, clamps ,support, flanges & ball valve etc as detailed below in specifications.

TECHNICAL SPECIFICATIONS & SCOPE OF WORK

1 The subject work include the removal of existing Replacement of existing 3 nos of Air vent pipe system installed at Overhead tank pipe line of Filter plant M-IIIA Panjrapur. 2 Successful quotationer shall supply the PPR Pipes, fittings, elbow, clamps ,support, flanges & ball valve as per the specifications & shall be designed for minimum 10 Kg/cm² test pressure.

• PPR Pipes:

- The pipes shall be of SDR 11, corrosion resistant pressure pipe. The pipe shall be use at temperature upto 80°C & pressure upto 10 Kg/cm². Pipe shall be Greater resistance to impact fracture and high temperature deflection, The jointing of the PP-R pipes and fittings are done by fusion welding, Fast and easy installation, Lower labor costs, no leakage, no scaling, no pitting, Low thermal expansion, Fire retardant, High impact strength, Low thermal conductivity & Shall not affected by chlorine in water system or by pH of water.
- The out side diameter of pipes should be 90 mm with 8 to 9 mm thickness & 110 mm with 10 to 11 thickness.
- Pipe Feetings: Fittings are to be manufactured from SDR 11 PPR material which meets ISO stsndard 15874. Complete air vent system should be of 90 mm (Outside diameter) & 110 mm (Outside diameter) size pipe & fittings. The jointing of the PP-R pipes and fittings are done by fusion welding.
- Flanges: Flange Should be PPR material should be of 90 mm (Outside diameter) & 110 mm (Outside diameter) size & shall be suitable for Air vent Pipe Sysytem. Hence it is necessary to identify the flange by visual observation & by taking physical measurement i.e number of bolts, bolt diameter, bolt Pitch Circle Diameter (PCD) and the flange thickness shall not be less than 9 mm.
- Clamp, Brackets Nut, Bolt, & Washers :- Clamps, brackets shall be suitable for air vent system. Use proper rubber packing for the same. Nuts and bolts shall be of best quality Stainless steel.
- Installation of Air Vent Pipe & Supports for pipes: PPR Air vent pipes shall be securely supported or suspended on hangers, clamps etc. as required. The contractor shall design all brackets, saddles, anchors, clamps etc. & shall be responsible for structural adequacy. Pipe supports shall be of steel SS 304. However successful quotationer shall submit proper drawings for supporting arrangement.
- Layout & Sizing of Pipes: The Contractor shall prepare and submit detailed drawings

- If any of the municipal property is unduly damaged due to negligence of the contractor, the contractor shall have to make it good to the satisfaction of BMC site engineer, without any extra cost to BMC.
