The Commissioner of Brihanmumbai Municipal Corporation invites E- quotation for the work as detailed below.

Bidding Process will comprise of THREE stages.

Bidder should note that the E-quotation Scrutiny fee of Rs.300/- + 18 % GST will be payable immediately after opening of Packet A & B in any of the Ward Citizens Facilitation Centers (CFCs) or will recover from EMD of concerned bidder as per Circular No. CA/FRG/03 dt. 11.05.2023.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Mahatenders) (<http://mahatenders.gov.in>). The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of CPD Byculla.

ii) The forms of Tender documents are available on the e-Tendering website <https://mahatenders.gov.in>. The aspiring Applicants will have to download Tender form, from the website mentioned above. The bidder has to fill in online format and upload information regarding Tender Online. Also he has to download the Tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.

iii) For purchasing the Tender documents, the bidders will have to get registered with e-tender portal (<https://mahatenders.gov.in>) for the etendering process and obtain login credentials to participate in the online Tender process. In terms of the 3 stage system of e-tendering, a Bidder will be required to deposit, along with its Bid, an **Earnest Money Deposit**. The “EMD” refundable in accordance to the relevant clause of bid document, from the Bid Due Date, except in the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. The e-tender is available on B.M.C. portal “<http://portal.mcgm.gov.in>” as well as on NIC portal (<https://mahatenders.gov.in>)

Eligibility Criteria

- 1) The quotationer(s) in their own name should have satisfactorily executed the work of similar nature MCGM /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which quotation is invited.
 - a) Three completed works of lifts maintenance/repairs each of value not less than the value equal to as mentioned in respective e quotation documents OR
 - b) Two completed works of lifts maintenance/repairs each of value not less than the value equal to as mentioned in respective e quotation documents OR
 - c) One completed works of lifts maintenance/repairs each of value not less than the value equal as mentioned in respective e quotation documents

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for quotations.

- 2) The Quotationer shall note the following criteria towards their eligibility.
 - a) Lift Manufacturer having authorization from Ch.Eng.(Elect.), PWD, Maharashtra State for Servicing and Maintenance of lifts.

OR

Firms dealing in this line having authorization from Ch. Eng. (Elect.), PWD Maharashtra State for servicing and maintenance of lifts.

- b) They shall also have service centre in Mumbai, Thane or Mumbai Metropolitan Region.

THE OFFERS WHICH DO NOT COMPLY WITH ABOVE ELIGIBILITY CRITERIA WILL NOT BE CONSIDERED.

Quotation Document: The blank quotation copy is available online only. The required documents and rate of quantity is to be submitted online through e-quotation.

Earnest Money Deposit(EMD):- The quotationers shall pay the Earnest Money Deposit online on or before **25.04.2024 till 16.00 hrs.**
