Subject: Work of fabrication, refurbishment and installation of shelves lockers and cupboards for the labour staff working under AEWV at F-south ward.

Bidding Process will comprise of THREE stages.

The application form can be downloaded from Mahatender portal (<http://www.mahatenders.gov.in>) on payment of ~~Rs.242.00 + 18% GST~~. The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-quotationing process & obtain login credentials to participate in the online bidding process.

As per circular No. CA/FRG/03 Dt.11.05.2023 the bid Scrutiny fee of Rs. 330/- + 18 % GST will be payable immediately after opening of Packet A & B in any of the Ward Citizens Facilitation Centers (CFCs) or will recover from EMD of concerned bidder as per Circular No. CA/FRG/10 dt. 19.10.2023.

i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of Account Officer (FAR), 3rd floor, Municipal Headquarter.

ii) Followed by SRM login ID and password to be obtained from Central Purchase Department (CPD), Office at Byculla, Bakariadda, Mumbai

iii) For registration, enrolment for digital signature certificates and user manual, please refer to respective links provided in 'quotations' tab. Vendors can get digital signature from any one of the Certifying Authorities (CA's) licensed by controller of certifying authorities namely, Safes crypt, IDRBT, National informatics center, TCS,CUSTOMS, MTNL, GNFC and e- Mudhra CA.

In terms of the 3 stage system of e-quotationing, a bidder will be required to deposit, along with its Bid, an Earnest Money Deposit of **Rs.3000.00 (Rupees Three Thousand only)** (the "EMD"), refundable in accordance to the relevant clause of bid document, from

the Bid Due Date, except in the case of the selected Bidder whose Bid Security/EMD shall be retained. The Bidders will have to provide Earnest Money Deposit through the payment gateways while submitting the bids. The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit.

Eligibility criteria

The quotationer(s) in their own name should have satisfactorily executed the work of similar nature BMC /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which bids are invited as a prime Contractor (or as a nominated sub-Contractor, where the subcontract had involved similar nature of work as described in the scope of works in this bid document, provided further that all other qualification criteria are satisfied)

a) Three similar completed works each of value not less than the value equal to cost put to quotation i.e. Rs. 60,000.00

OR

b) Two similar completed works each of value not less than the value equal to cost put to quotation i.e. Rs. 75,000.00

OR

c) One similar completed work of value equal and or not less than the cost put to quotation i.e. Rs.1,20,000.00

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for quotations.

For assessing the technical capacity of Regular, Routine and Maintenance works; Similar work shall mean, work of “fabrication and installation of lockers in BMC/Semi Govt./Govt. or Public sector Organization” as mentioned above in “Technical Capacity.”
