The Municipal Commissioner for Brihanmumbai Municipal Corporation invites e-quotations from Municipal registered vendors (on line only) for the following subject.

Bidding Process will comprise of THREE stages.

Scrutiny fee for this e-quotation is Rs. 330/- + 18% GST & shall be paid online only.

The application form can be downloaded from e-procurement system of Government of Maharashtra (Mahatenders) (<http://mahatenders.gov.in>). The applicants not registered with BMC are mandated to get registered (Vendor Registration) with BMC for e-tendering process & obtain login credentials to participate in the online bidding process.

- i) To download the application form, for those applicants not having vendor registration, need to apply first for vendor registration at the office of CPD Byculla.
- ii) The forms of Tender documents are available on the e-Tendering website <https://mahatenders.gov.in>. The aspiring Applicants will have to download Tender form, from the website mentioned above. The bidder has to fill in online format and upload information regarding Tender Online. Also he has to download the Tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.
- iii) For purchasing the Tender documents, the bidders will have to get registered with e-tender portal (<https://mahatenders.gov.in>) for the etendering process and obtain login credentials to participate in the online Tender process. In terms of the 3 stage system of e-quotation, a Bidder will be required to deposit, along with its Bid, an **Earnest Money Deposit of Rs. 3000.00 (Rupees Three Thousand only)** (the "EMD"). The Bid shall be summarily rejected if it is not accompanied by the Earnest Money Deposit. Eligibility Criteria : The quotationers in their own name should have **satisfactorily executed the works of regarding Ductable AC units or Air Handling Units** in MCGM /Semi Govt. /Govt & Public Sector Organizations during last seven (7) years ending last day of month previous to the one in which quotation is invited.

- a) Three similar completed works each of value not less than the value equal to Rs. 43,600/-
OR
- b) Two similar completed works each of value not less than the value equal to Rs. 54,501/-
OR
- c) One similar completed work of value equal and or not less than the Rs. 87,201/-.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10% per annum; calculated from the date of completion to last date of receipt of applications for quotations.
