Post Qualifying Criteria (Eligibility):

1) Post Qualification (Eligibility) Criteria:-

In case of firm dealing in line, the quotationer shall produce valid completion certificate or performance certificate in their own name for executing the work of similar nature in MCGM /Semi Govt. /Govt. & Public Sector Organizations during last seven (7) years.

For assessing the technical capacity of the subject work, similar work shall mean the completed or completed part of on-going 'works' in respect of "supply of eco-friendly paint/ supply & apply of paint/ wall painting/ IEC activity involving supply or application of paint" for BMC / Semi Govt. / Govt. & Public Sector Organizations during last seven (7) years. Any manufacturer/ authorized distributor/ resellers/ processors of eco friendly holi colors are eligible to apply for this quotation.

The eco-friendly holi colors, which are to be supplied to BMC offices should have Skin Safety Certification from any authorized agency / NABL Accredited Lab and any of the following certifications:-

1. Ecocert COSMOS certification ensuring environmentally friendly production, biodiversity respect, and no GMOs or petrochemical ingredients.
2. Ecomark (India) Environment-friendly product with low ecological impact
3. Any BIS/ ISO Certification / Lab Safety Reports (NABL Accredited Lab)
4. GreenPro ecolabel certification developed by the Confederation of Indian Industry (CII)'s Green Products & Services Council
5. Any Certification for environment friendly manufacturing of holi colors

The value of executed works shall be brought to current costing level by enhancing the actual value of work at compound rate of 10 % per annum; calculated from the date of completion to last date of receipt of applications for bid.

The Quotation shall be out rightly rejected if it is not accompanied by the Earnest Money Deposit as mentioned above. The Applicant has to prepare & submit quotation Documents offline on or before last date of submission as mentioned in quotation notice. The Applicant should submit the documents in readable form, The unreadable documents will be treated as null & void. The remaining documents will be evaluated. The decision of opening Authority regarding this will be binding to all applicants.
