Pre-Qualification Criteria: -

Quotationer shall specifically note following post qualification criteria towards technical ability:

1. The quotationer shall be registered as electrical contractor with Govt. of Maharashtra & shall submit the copy of license along with the quotation.
2. The quotationer shall have experience of "Work of Electrification" during last seven (7) years in any Municipal Corporation /Semi Govt. /Govt. & Public Sector Organizations. He/ She/ They shall submit documents in the evidence of that.

Note: If the quotationer failed to submit the documentary evidence of above point will be treated as non-responsive and 10 % amount of EMD will be forfeited for Non-responsiveness.

The last date of issue of quotation forms will be up to the day of the due date i.e. **07.02.2024 up to 03:00 Pm.**

Earnest Money deposit (EMD):

The quotationer shall pay E.M.D. of Rs.**3,000/-** by way of cash or Demand Draft drawn in favor of BRIHANMUMBAI MUNICIPAL CORPORATION payable at Mumbai.

The E.M.D. Receipt No. and date shall be clearly mentioned on the envelope.

Only Registered Municipal Suppliers (In case of supply only), having revised Standing Deposit according to their class & category, are exempted from payment of Earnest Money Deposit. However, it is mandatory on the Registered Municipal Suppliers to mention Standing Deposit Receipt No. on the quotation envelope and also enclose attested photo copy of the Standing Deposit Receipt along with the quotation.
